“WONDER CHANCE TO WIN” PROMOTION

TERMS AND CONDITIONS

1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entry is only open to participants of the “Wonder Recycling Rewards Program” (“Program”) who have registered their participation in the Program in accordance with the Program Terms and Conditions, available at www.wonder.com.au (“Eligible Entrants”).
3. Entry into the promotion opens at 6am AEST on 19/04/21 and closes at 11:59pm AEST on 08/05/21 (“Promotional Period”).
4. To receive an automatic entry, an Eligible Entrant must register their participation in the Program in accordance with the Program’s Terms and Conditions, during the Promotional Period.
5. Only one (1) entry is permitted per Eligible Entrant.
6. The Promoter reserves the right, at any time, to verify the validity of entries and Eligible Entrants and reserves the right, in its sole discretion, to disqualify any Eligible Entrant that the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. 10. Entries will be divided into the following State/Territory groups: NSW/ACT, VIC/TAS, SA/NT, QLD and WA. The first valid entry drawn in each State/Territory group will each win either a REPLAS Junior Exercise Circuit (if the winner is a primary school)
